- In a case involving a difficult trust beneficiary, Jeff successfully petitioned the court on behalf of the trustee to terminate the trust, discharge the trustee, and substitute an annuity for the beneficiary
- Jeff has assisted businesses and individuals in court cases and arbitrations involving contract disputes, breach of agent's duties, and recovery of property or money
- He has formed numerous non-profit charitable entities on behalf of clients and has successfully helped the entities obtain tax-exempt charity status
